For authors with multiple accepted papers, one full registration is valid for up to 2 papers. If you have more than 2 papers, a second registration will be required. The maximum number of pages per paper is six (6). You may purchase up to two (2) extra pages per paper at a cost of € 50 per page. Accepted and presented papers will be published in the IEEE ICAT 2017 Conference Proceedings and submitted to IEEE *Xplore*®.
